

Stack and learn with the **Stack & Sing Rings™!** Place the five rings on the wobbling base to discover fun sounds. Press the monkey to learn colors, numbers and shapes.

- (1) Rotate the packing locks 90 degrees counter-clockwise
- Pull out the packing locks

BATTERY INSTALLATION

- 1. Make sure the unit is turned OFF.
- 2. Locate the battery cover on the back of the unit. Use a screwdriver to loosen the screw.
- 3. Install 2 new AAA(AM-4/LR03) batteries following the diagram inside the battery box. (The use of new alkaline batteries is recommended for maximum performance.)
- Replace the battery cover and tighten 4. the screw to secure.



BATTERY NOTICE

- Use new alkaline batteries for maximum performance.
- Use only batteries of the same or equivalent type as recommended.
- Do not mix different types of batteries: alkaline, standard (carbonzinc) or rechargeable (Ni-Cd, Ni-MH), or new and used batteries.
- Do not use damaged batteries.
- Insert batteries with the correct polarity.
- Do not short-circuit the battery terminals.
- Remove exhausted batteries from the toy.
- Remove batteries during long periods of non-use.
- · Do not dispose of batteries in fire.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the toy before charging (if removable).
- Rechargeable batteries are only to be charged under adult supervision.

1. ON/OFF/VOLUME CONTROL SWITCH

To turn the unit ON, slide the ON/OFF/
VOLUME CONTROL SWITCH to
the LOW VOLUME (■)) or the HIGH
VOLUME (■))) position. To turn the unit
OFF (●), slide the ON/OFF/VOLUME
CONTROL SWITCH to the OFF (●)
position.



2. AUTOMATIC SHUT-OFF


To preserve battery life, the VTech® Stack & Sing Rings™ will automatically power-down after approximately 30 seconds without input. The unit can be turned on again by pressing any button or stacking the rings.

ACTIVITIES

 Slide the on/off/volume control switch to turn the unit on. You will hear playful sounds, a song and a fun phrase. The light will flash with the sound.



Press the monkey to learn about colors, numbers and shapes. You will also hear a variety of songs and melodies. The light will flash with the sound.



Stack the rings to hear a variety of playful sounds. After stacking five rings you will be rewarded with a playful song. The light will flash with the sound.

CARE & MAINTENANCE

TROUBLESHOOTING
